This is the proposed **Law in Washington State concerning Rockhounds** and collection of minerals, collection of dead wood, mushrooms, and berries. Note: this is Department of Fish and Wildlife rules and regulations not BLM or USFS. It also suggests Department Lands are not Public Land, but owned by the Department of Fish & Wildlife.

WSR 10-21-120  
PROPOSED RULES

[ Filed October 20, 2010, 11:48 a.m. ]

DEPARTMENT OF FISH AND WILDLIFE

Preproposal statement of inquiry was filed as WSR 10-02-074 on January 5, 2010.

Title of Rule and Other Identifying Information: WAC 232-12-251 Removal of minerals, wood and artifacts from department lands.

Hearing Location(s): Natural Resources Building, Room 172, 1111 Washington Street S.E., Olympia, WA 98501, on December 3-4, 2010, at 8:30 a.m.

Date of Intended Adoption: On or after January 7, 2011.

Purpose of the Proposal and Its Anticipated Effects, Including Any Changes in Existing Rules: The department currently lacks the ability to prohibit people from cutting down snags and taking mushrooms and berries on land it owns or controls.

Reasons Supporting Proposal: Snags provide habitat for many species. This proposal will protect that habitat from destruction. The proposal will also minimize the amount of downed dead wood that people can collect and use on the department's lands, and it will limit the amount of mushrooms that can be taken, to conserve these resources.

Statutory Authority for Adoption: RCW 77.04.012 and 77.12.047.

Statute Being Implemented: RCW 77.04.012 and 77.12.047.

Rule is not necessitated by federal law, federal or state court decision.

**100% Safe!**

**Interesting title, isn't it? Bet you never thought you could be 100% safe from anything, did you? Well, you can be almost perfectly safe in at least one aspect of this great hobby!**

**I'll borrow a topic from OSHA and my employer (before retirement) - ZES, or Zero Energy State. Here's the info: <OSHA regulation 1910.147> defines the unexpected movement or release of mechanical, electrical, hydraulic, pneumatic, chemical, or thermal energy as "hazardous". While this energy is vital to the operation of a facility, it must be properly controlled and isolated to help prevent its unexpected release during equipment maintenance.**

**Establishing a "zero energy state" is the best method of controlling hazardous electrical energy. What does this mean to you? Many of us may process our specimens in some fashion after collection. We'll use saws, sanders, polishers, faceters, and a myriad of other electrical devices in our processing. What would happen if a piece of equipment started when we didn't expect it to start? Saws can do obvious damage.**

Other rotating equipment may create a nasty abrasion. Any equipment with a pinch point (a drive belt going around a pulley, for example) that could draw in a finger or a part of clothing into it may cause an injury.

The answer - require more than one event for that equipment to be started. Most of us will simply turn off the switch on a device when done, or when taking a break. That's fairly safe if the switch is on the equipment, and reasonably protected against accidental operation. If the device is on an extension cord and plugged into a switch-controlled outlet somewhat removed from the device, then it's much less safe. The easy way to do this is to turn off the power switch AND unplug the tool. If the switch is accidentally engaged, nothing will happen because it's under zero energy. To be extra, super safe, also turn off the breaker controlling the equipment, such that it will require 3 events to happen before device operation (breaker on, plug in, switch on). In a manufacturing setting, one would disable the power source and lock it out with a personal, unique locking tag to absolutely create a safe environment.

One final point - many fairly modern devices have guards, which provide a barrier to pinch or danger points. The guard over saw blades, which protect you from the rotating blade, but pivot out of the way as the specimen is cut, is a good example of guarding. If your devices are not guarded, it would be advisable to find a commercial guard, create a home-made one, or at minimum provide a brightly colored warning near the danger point.

**No small business economic impact statement has been prepared under chapter 19.85 RCW. This rule only affects recreational use of department lands.**

**AMENDATORY SECTION(Amending Order 437, filed 5/11/90, effective 6/11/90)**

**WAC 232-12-251 Removal of minerals, wood and artifacts from department lands. (1) Except as provided below, it is unlawful to cut down or remove dead standing timber, live trees, wood, soil, petrified wood, minerals, fossils, ((wood products)) plants, mushrooms, berries, or artifacts from department lands unless such ((removal)) activity is authorized by a permit issued by the director.**

**(a) Downed dead wood for camping on department lands may be collected without a department permit in a quantity not to exceed one-half cord. However, such wood may not be transported from department lands.**

**(b) Mushrooms or berries may be collected for personal use without a permit in quantities not to exceed the following limits:**

**(i) For wild edible mushrooms, five United States gallons; and**

**(ii) For berries, no limit.**

**(2) Unlawful cutting down or removal of dead standing timber, live trees, wood, soil, petrified wood, minerals, fossils, or plants constitutes theft under chapter 9A.56 RCW.**

**(3) Unlawful removal or exceeding limits for downed dead wood, mushrooms, or berries is punishable under RCW 77.15.230.**

**[Statutory Authority: RCW 77.12.210 and 77.12.320. 90-11-049 (Order 437), § 232-12-251, filed 5/11/90, effective 6/11/90. Statutory Authority: RCW 77.12.040. 81-12-029 (Order 165), § 232-12-251, filed 6/1/81. Formerly WAC 232-12-550.]**

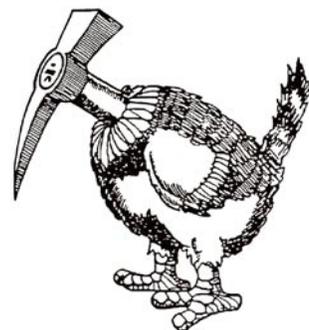
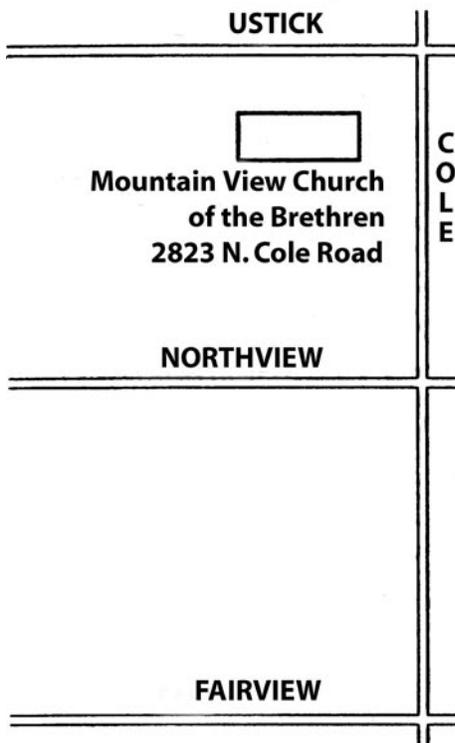
